PROGRAM AGREEMENT

1. 2. PAYMENT:

Client agrees to make one payment immediately of \$497.00 USD OR two payments of \$260.00 USD (the first payable immediately and the second to be automatically charged to Client's credit card on January 15, 2022)

Selected payment option:

- One time payment today of \$497.00
- Initial payment today of \$260.00 and second payment of \$260.00 on Jan. 15, 2022

3. CANCELLATION and REFUND POLICY:

If Client can demonstrate full participation in the Amplify 6-Week Program, including being present for or watching all session recordings and applying the program concepts, and is still not receiving the expected benefits, Speak Up will work with Client 1-1 to help Client get those results. If working individually does not yield the desired outcomes, Speak Up will give a full refund to Client.



4. **LIABILITY:**

Speak Up's liability in contract, tort or otherwise arising through or in connection with this Agreement or through or in connection with the completion of obligations under this Agreement shall be limited to Fees paid by the Client to Speak Up in the most recent 12-month period. To the extent it is lawful, neither party shall be liable to the other party in contract, tort, negligence, breach of statutory duty or otherwise for any loss, damage, costs or expenses of any nature whatsoever incurred or suffered by that other party of an indirect or consequential nature including without limitation any economic loss, data loss, loss of goodwill, or other loss of turnover, profits, or business.

5. **CONFIDENTIALITY:**

The existence of this coaching relationship, as well as any information that Speak Up receives from Client, are to be fully and completely confidential under the terms of this Agreement. Speak Up will not disclose Client's name or any of Client's information without Client's written consent, unless subject to a legal requirement, such as a court order, subpoena, or law enforcement inquiry.

If Client provides written or video testimonials during or after the Amplify 6-week program, Client agrees that Speak Up may use them with Client's name and image in any and all printed and digital formats for promotional use, unless otherwise specified in writing by Client when providing the testimonial.

Client understands that all sessions will be recorded and these recordings will be made available to all current and future Amplify Clients. If Client wishes for their name or image to be removed from session videos, Client must notify Speak Up in writing before the start of the 6-week program.

6. This Agreement and the Services provided are governed by North Carolina law. Speak Up and Client agree to try to resolve all disputes amicably, but any dispute must be brought in the state or federal courts located in Raleigh, NC.
